Through mutual respect and understanding, enhance the quality of life in Tribal communities by building capacity for Tribes to administer and manage their transportation programs and systems.




SWTTAP MISSION

NEWS & UPDATES

TTP Online Reporting System

The federal fiscal year 2023 ended on September 30, TTP annual reports covering the entire 2023 federal fiscal year (October 2022 – September 2023) are due by December 31, 2023. Electronic reporting is required by 25 CFR 170.240. To access the TTP Online Reporting System, formerly known as PORT, please follow these links:

- 1. Financial Report <u>Link</u> (hold CTRL, then select with your mouse)
- 2. Non-construction Activities Report Link
- 3. A Project Report for each project that was active during the reporting period <u>Link</u>

The data you enter into the TTP Online Reporting
System will be used within the FAST Act required
reports to the Secretaries of the Department of
Transportation and Department of Interior. It is
essential that reports be completed no later than
December 31. Please complete the reports for the
Financial Report, Non-construction Activities Report,
and for each Project that has been active during the
2023 federal fiscal year. Click on the Project link
provided for any projects not listed on your TTIP.

Please note, fill a response for each question as the system will not allow you to submit with blanks in any question. This year there is no time limitation which will close your application. We are providing pdf copies of each report as some have to coordinate between individuals or offices to complete the report.

To assist you with navigating the TTP Online Reporting System, a PORT Overview webinar will be held on October 17, 2023. Details on the webinar will be available later from your FHWA or BIA POC. You can also submit questions about the new PORT through your FHWA or BIA POC.

NEWS & UPDATES

TTP - Tribal Transit Program

FTA is conducting a consultation with Tribal Nations and requesting comments related to the <u>Tribal Transit Program</u> (TTP). Under the Biden-Harris Administration, FTA's Tribal Transit Program has grown significantly. Compared to the Federal support before 2021, our current annual funding for Tribal formula and competitive programs has increased by 31 percent.

FTA is increasing technical assistance efforts at the national and regional levels to ensure Tribal leaders and grant managers have the tools they need to successfully apply for grants and run efficient transit programs. This consultation reflects FTA's commitment to ensuring our programs and policies are responsive to Tribal needs and part of a formal process to ensure the TTP is well-administered alongside increased funding available, a growing number of Tribes participating and other programmatic changes.

FTA issued a <u>notice</u> in the Federal Register seeking comment on how the FTA's Tribal Transit competitive program and technical assistance are administered. The first consultation was held in person in Anchorage last month as part of the National Transportation in Indian Country annual conference.

Learn more and provide feedback during this <u>virtual</u> <u>consultation</u> scheduled for Thursday, November 2 at 2 PM ET. There will be an opportunity for participants to provide feedback and comments.

The NTICC carries on the tradition of creating Tribal transportation conferences FOR TRIBES, BY TRIBES. The NTICC is hosted by The Center for Tribal Transportation and is planned and organized by a Planning Committee comprised of Tribal transportation professionals across the U.S.

NTICC was attended by Tribes from across the U.S., Federal partners from USDOT, FHWA, NHTSA, FTA, FRA, MARAD, FMCSA, BIA and other organizations that are dedicated to furthering Tribal Transportation.

There were over 30 vendor exhibitors and 8 local artist vendors, NTICC was closed out with a memorable performance by Grammy winner Pamyua!

NTICC featured 90 learning sessions in 8 conference tracks tailored to fit the transportation related professional development needs in Indian Country. These included: Workforce Development, Transit, TTP 101, Safety, Hot Topics, Planning, Leadership & Infrastructure Bill, and Project Management & Maintenance. We also had the highly anticipated one of a kind Heavy Equipment Roadeo Team Competition.

FUNDING OPPORTUNITIES

TRANSPORTATION FUNDING OPPORTUNITIES FOR TRIBAL NATIONS

in 2022, FHWA published the <u>Transportation Funding Opportunities for Tribal Nations</u>. The purpose of this document is to provide information to Tribes on new and existing highway and bridge transportation funding programs for which Tribes are eligible.

TRIBAL TRANSPORTATION PROGRAM SAFETY FUND

APPLICATION DEADLINE: October 1, 2023 - January 15, 2024

SUMMARY: The FY2022-2026 TTP Safety Fund Notice of Funding Opportunity (NOFO) for the TTP Safety Fund was published on June 7, 2022 and amended on January 9, 2023. Applications for the FY2024 funding cycle will be accepted October 1, 2023 through January 15, 2024.

Eligible applicants may submit multiple applications by following these steps for each project:

Review the FY2022-2026 TTP Safety Fund Notice of Funding Opportunity (NOFO).

Complete an application form.

Review the decision chart in the TTPSF Application Guide (PDF) (DOCX) to determine if a project narrative or other documentation is required.

Submit applications by email attachment to TTPSF@DOT.gov. If your application is too large to send by email (FHWA can only recieve <24MB) please email TTPSF@dot.gov to request an upload link.

2023 NATIONALLY SIGNIFICANT FEDERAL LANDS AND TRIBAL PROJECTS PROGRAM

APPLICATION DEADLINE: November 6, 2023

SUMMARY: The Fixing America's Surface Transportation (FAST) Act established the NSFLTP Program to provide Federal financial assistance to projects of national significance for construction, reconstruction, or rehabilitation of transportation facilities within, adjacent to, or providing access to Federal or Tribal lands. The Infrastructure Investment and Jobs Act (Pub. L. 117-58, November 15, 2021, "Bipartisan Infrastructure Law," or "BIL") modified the program in several ways, including providing \$55 million per year from the Highway Trust Fund, as well as authorizing up to an additional \$300 million per year from the General Fund, for each of FYs 2022 through 2026. The BIL also reduced minimum project sizes from \$25 million to \$12.5 million, directed 50 percent of the funds towards Tribal transportation facilities, increased the Federal share of projects on Tribal transportation facilities to 100 percent and required funding of at least one eligible project submitted by the National Park Service for a unit of the National Park System with 3,000,000 annual visitors or more.

TTP BRIDGE PROGRAM

DESCRIPTION: The TTP Bridge Program is focused on improving the number of TTP bridges in poor condition. Federally recognized Indian Tribes may submit an application at any time for eligible TTP bridges for planning, design, engineering, preconstruction, construction, and inspection of new or replacement bridges. SUMMARY

The Office of Tribal Transportation (OTT) administers the Tribal Transportation Program (TTP) and provides stewardship and oversight for direct funding agreements with 135 federally recognized Tribes. The OTT also provides support for all FHWA activities affecting tribal transportation. This support includes the administration of the Rebuilding American Infrastructure with Sustainability and Equity (RAISE) discretionary grants program awarded to Tribes, and the transfer of funds from States and other local governments to Tribes through the 202(a)(9) transfer process.

In addition, the FHWA Office of Tribal Transportation manages the Tribal Transportation Program Bridge Program and the Tribal Transportation Program Safety Fund for all federally recognized Tribes. These grant programs are set-asides from the overall Tribal Transportation Program.
